

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0487**

*Affirmed*  
*Late Request for Hearing Allowed*  
*Request to Reopen Allowed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On March 16, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving benefits effective February 2, 2020 (decision # 122019). On April 6, 2020, decision # 122019 became final without claimant having filed a timely request for hearing. On April 9, 2020, claimant filed a late request for hearing. On April 15, 2020, ALJ Kangas reviewed claimant's request and issued Order No. 20-UI-148074, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by April 29, 2020. On April 27, 2020, claimant filed a timely response to the questionnaire. On April 28, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for May 12, 2020 at 8:15 a.m. to consider claimant's late request for hearing, and if granted, the merits of decision # 122019.

On May 12, 2020, ALJ Roberts conducted a hearing at which the employer failed to appear, and on May 13, 2020, issued Order No. 20-UI-149646 allowing claimant's late request for hearing and concluding that the employer discharged claimant not for misconduct. On May 30, 2020, the employer filed a request to reopen the May 12, 2020 hearing. On June 3, 2020, OAH mailed notice of a hearing scheduled for June 15, 2020 to consider the employer's request to reopen, and if allowed, claimant's late request for hearing, and the merits of decision # 122019. On June 15, 2020, ALJ Roberts conducted a hearing at which claimant and the employer appeared, and on June 22, 2020, issued Order No. 20-UI-151343, allowing the employer's request to reopen and claimant's late request for hearing, and concluding again that the employer discharged claimant not for misconduct. On June 24, 2020, the

employer filed an application for review of Order No. 20-UI-151343 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-151343 is affirmed.
