

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0492**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On March 12, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct and claimant was disqualified from receiving benefits effective February 9, 2020. Claimant filed a timely request for hearing. On April 9, 2020, ALJ Snyder conducted a hearing, at which claimant appeared, and on April 15, 2020, issued Order No. 20-UI-148128 affirming the Department's decision. On May 5, 2020, Order No. 20-UI-148128 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 25, 2020, claimant filed a late application for review of Order No. 20-UI-148128 with EAB.

**FINDINGS OF FACT:** (1) Order No. 20-UI-148128 stated that any appeal of the order must be filed within 20 days of the date the decision was mailed, or by May 5, 2020, to be timely. Order No. 20-UI-148128 at 4.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 20-UI-148128 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-148128 was due May 5, 2020. Because claimant did not file their application for review until June 25, 2020, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the May 5, 2020 deadline. Accordingly, claimant did

not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed June 25, 2020 is dismissed. Order No. 20-UI-148128 remains undisturbed.
