EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0497

Affirmed Requests to Reopen Denied

PROCEDURAL HISTORY: On March 19, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective November 17, 2019 (decision #82737). On April 8, 2020, decision #82737 became final without claimant having filed a request for hearing. On April 9, 2020, the Department served notice of another administrative decision, based in part on decision #82737, concluding that claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessing a \$4,119 overpayment, \$1,235.70 monetary penalty, and a 31-week disqualification from future benefits. On April 29, 2020, the April 9, 2020 decision became final without claimant having filed a request for hearing.

On April 30, 2020, claimant filed late requests for hearings on decision #82737 and the April 9, 2020 decision. On May 20, 2020, the Office of Administrative Hearings (OAH) mailed claimant notice of a hearing scheduled for June 2, 2020 at 10:45 a.m. to address whether claimant had good cause for their late request for hearing on the April 9, 2020 decision, and if so, the merits of that decision. On May 22, 2020, OAH mailed claimant notice of a hearing scheduled for June 2, 2020 at 9:30 a.m. to address whether claimant had good cause for their late request for hearing on decision #82737, and if so, the merits of that decision. On June 2, 2020, claimant failed to appear at both hearings, and ALJ Frank

issued Orders No. 20-UI-150522 and 20-UI-150524, dismissing claimant's late requests for hearing for failure to appear, leaving decision #82737 and the April 9, 2020 decision undisturbed.

On June 6, 2020, claimant filed timely requests to reopen the two June 2, 2020 hearings. ALJ Kangas considered claimant's requests, and on June 16, 2020 issued Orders No. 20-UI-151110 and 20-UI-151112, denying the requests. On June 25, 2020, claimant filed timely applications for review of Orders No. 20-UI-151110 and 20-UI-151112 with the Employment Appeals Board (EAB). Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-151110 and 20-UI-151112. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0498 and 2020-EAB-0497).

EAB did not consider the written arguments claimant submitted with their applications for review when reaching these decisions because they did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The arguments also contained new information regarding claimant's failure to appear at the June 2nd hearings, and claimant did not show, as required by OAR 471-041-0090 (May 13, 2019), that factors or circumstances beyond their reasonable control prevented them from offering the information with their request to reopen the hearings as required by OAR 471-040-0040(3) (February 10, 2012). EAB therefore did not consider claimant's written arguments or new information when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire consolidated case records. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 20-UI-151110 and 20-UI-151112 are affirmed.
