

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0499

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 1, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessed a \$4,978 overpayment, a \$1,493.40 monetary penalty, and a penalty disqualification from future benefits of 52 weeks (decision # 203646). Claimant filed a timely request for hearing. On June 22, 2016, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for July 7, 2016 at 1:30 p.m. On July 7, 2016, claimant failed to appear for the hearing, and ALJ Vincent issued Order No. 16-UI-63366 dismissing claimant's request for hearing for that reason, leaving decision # 203646 undisturbed. On July 27, 2016, Order No. 16-UI-63366 became final without claimant having filed a timely request to reopen the July 7, 2016 hearing.

On April 24, 2020, claimant filed a late request to reopen the July 7, 2016 hearing. ALJ Kangas reviewed claimant's request, and on June 2, 2020, issued Order No. 20-UI-150543, denying claimant's late request to reopen, leaving Order No. 16-UI-63366 undisturbed. On June 22, 2020, Order No. 20-UI-150543 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 29, 2020, claimant filed a late application for review of Order No. 20-UI-150543 with EAB.

FINDING OF FACT: (1) Order No. 20-UI-150543 stated that any appeal of the order must be filed within 20 days of the date the decision was mailed, by June 22, 2020, to be timely. Order No. 20-UI-150543 at 3.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-150543 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable

control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-150543 was due June 22, 2020. Because the appellant did not file their application for review until June 29, 2020, the application for review was late. Claimant provided a written statement with their application for review. However, claimant’s written statement provided no information as to why claimant filed the application after the filing deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

DECISION: The application for review filed June 29, 2020 is dismissed. Order No. 20-UI-150543 remains undisturbed.
