# EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0503

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On September 27, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, and claimant was disqualified from receiving unemployment insurance benefits effective September 1, 2019 (decision #121445). Claimant filed a timely request for hearing. On October 2, 2019, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for October 16, 2019 at 4:30 p.m. On October 16, 2019, claimant failed to appear for the hearing, and on October 17, 2019 ALJ Frank issued Order No. 19-UI-138237 dismissing claimant's request for due to claimant's failure to appear, leaving decision #121445 undisturbed.

On October 17, 2019, claimant filed a timely request to reopen the October 16, 2019 hearing. On October 22, 2019, OAH served, by mail, notice of a telephone hearing scheduled for November 5, 2019 at 9:30 a.m. to consider claimant's request to reopen, and if granted, the merits of decision # 121445. On November 5, 2019, ALJ Snyder conducted a hearing at which claimant appeared, and on November 13, 2019 issued Order No. 19-UI-139702, denying claimant's request to reopen, leaving Order No. 19-UI-138237 undisturbed. On December 3, 2019, Order No. 19-UI-139702 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On June 25, 2020, claimant filed a late application for review of Order No. 20-UI-139702 with EAB.

**FINDING OF FACT:** (1) Order No. 19-UI-139702 stated that any appeal of the order was required to be filed within 20 days of the date the decision was mailed, meaning by December 3, 2019, to be timely. Order No. 19-UI-139702 at 3.

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 19-UI-139702 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable

control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 19-UI-139702 was due to EAB by December 3, 2019. Because claimant did not file their application for review until June 25, 2020, the application for review was late. Claimant provided a written statement with their application for review. However, claimant's written statement only stated, "Black Lives Matter. This was unfair," and provided no information as to why claimant filed the application for review with EAB after the filing deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed June 25, 2020 is dismissed. Order No. 19-UI-139702 remains undisturbed.
