

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0504

Application for Review Dismissed
No Disqualification

PROCEDURAL HISTORY AND FINDINGS OF FACT: On March 13, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily quit work without good cause (decision # 115414). On April 3, 2020, decision # 115414 became final without claimant having filed a request for hearing. On April 19, 2020, claimant filed a late request for hearing. On May 14, 2020, ALJ Kangas issued Order No. 20-UI-149776, dismissing claimant's request for hearing as late without a showing of good cause, subject to his right to renew his request by filing a response to an appellant questionnaire by May 28, 2020. On June 3, 2020, claimant filed a response to the appellant questionnaire. On June 5, 2020, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 20-UI-149776 was cancelled and vacated, and served notice of a hearing for June 18, 2020 on whether claimant's late request for hearing should be allowed and, if so, the merits of decision #115414. On June 18, 2020, ALJ Wymer conducted a hearing and issued Order No. 20-UI-151243, allowing claimant's late request for hearing and concluding the employer discharged claimant, not for misconduct, and that claimant was not disqualified from receiving unemployment insurance benefits. On June 29, 2020, claimant filed an application for review of Order No. 20-UI-151243 with the Employment Appeals Board (EAB).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 20-UI-151243 presents no justiciable controversy, and therefore is dismissed.

Claimant appealed an order that did not disqualify him from receiving benefits. In his application for review, claimant did not assign error to any portion of the order, nor did he request reversal of any part of the order. In consideration of EAB's obligation to issue decisions that are consistent with sound principles governing judicial review and address only existing controversies between parties, we decline to address matters that will have no practical effect on the rights of the parties to the controversy. *See Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995); *Brumnett v. PSRB*, 315 Or 402, 848 P2d 1194 (1992).

DECISION: The application for review filed June 29, 2020 is dismissed. Order No. 20-UI-151243 remains undisturbed.
