EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0515

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 17, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessed a \$2,849 overpayment, a \$854.70 monetary penalty, and a penalty disqualification from future benefits of 19 weeks (decision # 194980). Claimant filed a timely request for hearing. On March 19, 2020, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for April 3, 2020 at 8:15 a.m. at which claimant failed to appear. On April 7, 2020, ALJ Wyatt issued Order No. 20-UI-147574 dismissing claimant's request for hearing because claimant failed to appear for the April 3, 2020 hearing, leaving decision # 194980 undisturbed. On April 27, 2020, Order No. 20-UI-147574 became final without claimant having filed a timely request to reopen the April 3, 2020 hearing.

On May 7, 2020, claimant filed a late request to reopen the April 3, 2020 hearing. ALJ Kangas reviewed claimant's request, and on June 11, 2020, issued Order No. 20-UI-150927, denying the request, leaving Order No. 20-UI-147574 undisturbed. On July 1, 2020, Order No. 20-UI-150927 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 6, 2020, claimant filed a late application for review of Order No. 20-UI-150927 with EAB.

EAB considered claimant's written argument in reaching this decision.

FINDING OF FACT: (1) Order No. 20-UI-150927 mailed on June 11, 2020 stated, "You may appeal this decision by filing the attached Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 20-UI-150927 at 4. Order No. 20-UI-150927 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 1, 2020 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-150927 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing

period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-150927 was due July 1, 2020. Because claimant did not file their application for review until July 6, 2020, the application for review was late. Claimant provided a written statement with their application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed July 6, 2020 is dismissed. Order No. 20-UI-147574 remains undisturbed.
