EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0519

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On February 12, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision assessing a 20-week penalty disqualification from future benefits payable based upon claimant's misrepresentations about his earnings and a work separation (decision # 200255). On March 4, 2019, decision # 200255 became final without claimant having filed a timely request for hearing. On April 23, 2020, claimant filed a late request for hearing. On May 26, 2020, ALJ Kangas issued Order No. 20-UI-150242, dismissing claimant's late request for hearing subject to his right to renew the request by responding to an appellant questionnaire no later than June 9, 2020. On June 2, 2020, claimant responded to the appellant questionnaire. On June 10, 2020, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 20-UI-150242 was canceled. On June 17, 2020, OAH mailed notice of a hearing scheduled for July 1, 2020. On July 1, 2020, ALJ Frank conducted a hearing, and on July 2, 2020 issued Order No. 20-UI-151806, redismissing claimant's late request for hearing on decision # 200255. On July 7, 2020, claimant filed an application for review of Order No. 20-UI-151806 with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) Claimant did not receive notice of the February 12, 2019 decision when it was mailed to him. Claimant was living out-of-state for work, and also had experienced some mail theft at his address of record.

(2) On March 16, 2020, claimant became aware of decision # 200255. He did not file a late request for hearing until April 23, 2020.

(3) Claimant thought that having penalty weeks meant that he could not apply for unemployment for 20 weeks. He did not understand that the penalty weeks would continue to apply to his claim after a year had passed.

CONCLUSIONS AND REASONS: Claimant's late request for hearing should be dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

The circumstance that prevented claimant from filing a timely request for hearing is that he was not aware that the Department had issued its February 12th decision. That circumstance ceased to exist in mid-March 2020, when claimant became aware that the Department had imposed penalty weeks. Although claimant was aware of the decision in March 2020, he did not file his late request for hearing on that decision until about a month later, on April 23, 2020. Because claimant waited more than seven days to file his late request for hearing, he did not file his late request within the seven-day "reasonable time" period. Because he did not file within a "reasonable time," his late request for hearing must be dismissed.

DECISION: Order No. 20-UI-151806 is affirmed.
