

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0524

Affirmed
No Disqualification

PROCEDURAL HISTORY: On April 28, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and disqualifying her from benefits as of January 12, 2020 (decision # 180343). Claimant filed a timely request for hearing. On June 18, 2020, ALJ Roberts conducted a hearing, and on June 24, 2020 issued Order No. 20-UI-151417 concluding that claimant quit with good cause. On July 10, 2020, the employer filed an application for review with the Employment Appeals Board (EAB).

The employer's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

The employer asserted that the hearing proceedings were unfair or the ALJ was biased. EAB reviewed the hearing record in its entirety, which shows that the ALJ inquired fully into the matters at issue and gave all parties reasonable opportunity for a fair hearing as required by ORS 657.270(3) and (4) and OAR 471-040-0025(1) (August 1, 2004).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-151417 is affirmed.
