

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0526

Affirmed
No Disqualification

PROCEDURAL HISTORY: On May 26, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective March 15, 2020 (decision # 105729). Claimant filed a timely request for hearing. On July 2, 2020, ALJ Roberts conducted a hearing, and on July 6, 2020 issued Order No. 20-UI-151844, concluding claimant quit work with good cause. On July 14, 2020, the employer filed an application for review with the Employment Appeals Board (EAB).

On July 14, 2020, the employer submitted written argument with the employer's application for review. EAB did not consider the employer's July 14 written argument when reaching this decision because they did not include a statement declaring that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019).

On July 24, 2020, the employer submitted another written argument and provided a copy to the other parties. The employer's July 24 argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-151844 is affirmed.
