

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0529

*Affirmed ~ Late Request for Hearing Dismissed
Ineligible*

PROCEDURAL HISTORY: On April 1, 2020, the Oregon Employment Department (Department) served notice of two administrative decisions. One concluded that claimant was not available for work and was ineligible for unemployment insurance benefits from February 9, 2020 through February 15, 2020 (decision # 104146), and another concluded that claimant was not available for work and was ineligible for benefits from February 23, 2020 through February 29, 2020 and until the reason for the denial had ended (decision # 105547). On April 21, 2020, decisions # 104146 and 105547 became final without claimant having filed requests for hearings. On May 13, 2020, claimant filed a late request for hearing on decisions # 104146 and 105547. On June 8, 2020, ALJ Kangas issued Order No. 20-UI-150793 dismissing claimant's late request for hearing on decision # 105547 subject to claimant's right to renew the request by responding to an appellant questionnaire by June 22, 2020. On June 9, 2020, ALJ Kangas issued Order No. 20-UI-150814 dismissing claimant's late request for hearing on decision # 104146 subject to claimant's right to renew the request by responding to an appellant questionnaire by June 23, 2020. On June 22, 2020, claimant filed a timely response to the appellant questionnaires. ALJ Kangas reviewed claimant's response, and June 24, 2020 issued Order No. 20-UI-151460 re-dismissing claimant's late request for hearing on decision # 104146, and Order No. 20-UI-151468 re-dismissing claimant's late request for hearing on decision # 105547.

On July 14, 2020, claimant filed timely applications for review of Orders No. 20-UI-151460 and 20-UI-151468. Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-151460 and 20-UI-151468. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0530 and 2020-EAB-0529). EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), Orders No. 20-UI-151460 and 20-UI-151468 are **adopted**.

DECISION: Orders No. 20-UI-151460 and 20-UI-151468 are affirmed. Decisions # 104146 and 105547 remain undisturbed.
