EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0531

Late Application for Review Dismissed

PROCEDURAL HISTORY: On January 14, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$706 overpayment, a \$105.90 monetary penalty, and a penalty disqualification from future benefits of 5 weeks (decision # 200258). Claimant filed a timely request for hearing. On March 10, 2020, ALJ Wyatt conducted a hearing, and on March 18, 2020, issued Order No. 20-UI-146458 modifying the Department's decision by concluding that claimant was overpaid \$706 in benefits that he was liable to repay to the Department, but that he was not assessed a monetary penalty or disqualification from future benefits. On April 7, 2020, Order No. 20-UI-146458 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On July 16, 2020, claimant filed a late application for review of Order No. 20-UI-146458 with EAB.

FINDING OF FACT: Order No. 20-UI-146458 stated that any appeal of the order must be filed within 20 days of the date the decision was mailed, by April 7, 2020, to be timely. Order No. 20-UI-146458 at 4.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-146458 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-146458 was due April 7, 2020. Because claimant did not file their application for review until July 16, 2020, the application for review was late. Claimant's application for review included the following written statement:

i really d.ont know what im doing. im filing because i apparently didn't receive the proper notification...i live in a community type setting where letters have been misplaced this is why im asking for consideration.

Claimant's Application for Review (verbatim). However, claimant's written statement did not state that he did not receive Order No. 20-UI-146458 or that he received it late, and did not state when and how he became aware of the order. Rather, it only suggested that he did not receive "the proper notification." Because his written statement did not describe circumstances beyond his reasonable control that prevented a timely filing or that he filed his application for review within seven days after those circumstances ceased to exist, claimant did not show good cause for the late application for review. Accordingly, claimant's late application for review is dismissed.

DECISION: The application for review filed July 16, 2020 is dismissed. Order No. 20-UI-146458 remains undisturbed.
