

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0532**

*Application for Review Dismissed  
No Disqualification*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On October 22, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective April 28, 2019 (decision # 140621). On November 12, 2019, decision # 140621 became final without claimant having filed a request for hearing.

On May 22, 2020, claimant filed a late request for hearing. On June 10, 2020, ALJ Kangas issued Order No. 20-UI-150905, dismissing claimant's request for hearing as late without a showing of good cause, subject to her right to renew her request by filing a response to an appellant questionnaire by June 24, 2020. On June 17, 2020, claimant filed a timely response to the appellant questionnaire. On June 24, 2020, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 20-UI-150905 was vacated, and that a hearing would be scheduled to consider claimant's late hearing request, and if granted, the merits of decision # 140621. On June 30, 2020, OAH mailed notice of a hearing scheduled for July 13, 2020 at 9:30 a.m.

On July 13, 2020, ALJ McGorin conducted a hearing and issued Order No. 20-UI-152127, allowing claimant's late request for hearing, and concluding claimant voluntarily left work with good cause and was not disqualified from receiving unemployment insurance benefits. On July 15, 2020, claimant filed an application for review of Order No. 20-UI-152127 with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** Claimant's application for review of Order No. 20-UI-152127 presents no justiciable controversy and should be dismissed.

On July 15, 2020, EAB received from claimant a timely application for review of an order that allowed claimant benefits. Claimant did not assign error to any portion of that order, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. In consideration of EAB's obligation to issue decisions that are consistent with sound principles governing judicial review and address only existing controversies between parties, EAB declines to

address matters that will have no practical effect on the rights of the parties to the controversy. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995); *Brumnett v. PSRB*, 315 Or 402, 848 P2d 1194 (1992). Accordingly, claimant's application for review is dismissed.

**DECISION:** The application for review filed July 15, 2020 is dismissed. Order No. 20-UI-152127 remains undisturbed.
