

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0534**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On April 30, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily quit work without good cause and was disqualified from receiving benefits effective March 15, 2020. (decision # 110719). Claimant filed a timely request for hearing. On July 6, 2020, ALJ Murdock conducted a hearing, and on July 7, 2020, issued Order No. 20-UI-151930, affirming the Department's decision. On July 16, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Each party presented written argument regarding claimant's application for review. Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). To the extent claimant asserted that the hearing proceedings were unfair or the ALJ was biased, EAB reviewed the hearing record in its entirety, which shows that the ALJ inquired fully into the matters at issue and gave all parties reasonable opportunity for a fair hearing as required by ORS 657.270(3) and (4) and OAR 471-040-0025(1) (August 1, 2004). The employer declared that they provided a copy of their argument to the opposing party as required by OAR 471-041-0080(2)(a). EAB considered only information received into evidence at the hearing and the employer's written argument when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-151930 is affirmed.
