EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0543

Affirmed Disqualification

PROCEDURAL HISTORY: On June 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective February 16, 2020 (decision # 81915). Claimant filed a timely request for hearing. On July 8, 2020, ALJ Logan conducted a hearing, and on July 9, 2020 issued Order No. 20-UI-152008, affirming the Department's decision. On July 24, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted written argument to EAB. Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Claimant provided new information about his employment with Thirsty Lion Gastropub and Grill. Claimant's Written Argument. Claimant asserted that his earnings from that employer were not included on his Wage and Potential Benefit Report for the benefits claim at issue, and that he was unable to have those earnings added to the report because he was unable to contact anyone at the Department due to its busy telephone lines. Claimant's Written Argument. Although claimant's earnings from Thirsty Lion Gastropub and Grill were not on claimant's Wage and Potential Benefit Report, claimant does not show that such omission was a factor or circumstance that prevented him from offering information about his employment with Thirsty Lion Gastropub and Grill at hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the hearing record in its entirety, which shows that the ALJ inquired fully into the matters at issue and gave all parties reasonable opportunity for a fair hearing as required by ORS 657.270(3) and (4) and OAR 471-040-0025(1) (August 1, 2004). When claimant was asked at hearing why he left work with Pizzicato, he did not mention Thirsty Lion Gastropub and Grill. Audio Record at 11:50 to 13:13. When claimant was asked at hearing if there was "any other reason" he left Pizzicato, claimant did not mention Thirsty Lion Gastropub and Grill. Audio Record at 18:42 to 19:34. Nor did any of the record documents or documents submitted by claimant for hearing contain information about Thirsty Lion Gastropub and Grill. Exhibit 1.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-152008 is affirmed.
