

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0544**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On December 3, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment benefits effective August 18, 2019 (decision # 153019). On December 23, 2019, decision # 153019 became final without claimant having filed a timely request for hearing.

On May 29, 2020, claimant filed a late request for hearing. On June 22, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 6, 2020 to consider claimant's late request for hearing, and if granted, the merits of decision # 153019. On July 6, 2020, ALJ Wymer conducted a hearing, and on July 7, 2020, issued Order No. 20-UI-151895, denying claimant's late request for hearing as without good cause, leaving decision # 153019 undisturbed. On July 17, 2020, claimant filed a timely application for review of Order No. 20-UI-151895 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-151895 is affirmed.
