

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0548**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On December 9, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant failed to provide the Department with required information in accordance with Department rules and denying benefits for the week of November 17 through November 23, 2019, and until the reason for the denial had ended. On December 30, 2019, the Department's December 9, 2019 decision became final without claimant having filed a timely request for hearing.

On May 28, 2020, claimant filed a late request for hearing. On July 13, 2020, ALJ Kangas issued Order No. 20-UI-152096, dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 27, 2020. On July 17, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's questionnaire response, and on July 22, 2020, issued Order No. 20-UI-152422, concluding claimant did not show good cause for the late request for hearing, canceling Order No. 20-UI-152096 and re-dismissing claimant's late request for hearing, leaving the administrative decision dated December 9, 2019 undisturbed. On July 27, 2020, claimant filed a timely application for review of Order No. 20-UI-152422 with the Employment Appeals Board (EAB).

With their application for review, claimant submitted a written argument. EAB considered claimant's argument to the extent it was based on the hearing record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-152422 is affirmed.
