EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0552-R

Affirmed
No Disqualification

PROCEDURAL HISTORY: On May 28, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause (decision #73112). Claimant filed a timely request for hearing. On July 21, 2020, ALJ Roberts conducted a hearing, and on July 22, 2020 issued Order No. 20-UI-152410, concluding that claimant quit work with good cause. On July 28, 2020, the employer filed an application for review with the Employment Appeals Board (EAB). On August 12, 2020, EAB issued EAB Decision 2020-EAB-0552, adopting Order No. 20-UI-152410. On August 14, 2020, EAB received the employer's timely written argument.

EAB erred by issuing the decision in this matter before the expiration of the written argument due date. This decision is therefore issued pursuant to EAB's authority under ORS 657.290(3) to reconsider previous decisions of EAB upon our own motion.

Order No. 20-UI-152410 previously concluded that claimant quit work "because he reasonably believed he was at risk of contracting the norovirus at work and bringing it home to his aged, health-challenged parents." Order No. 20-UI-152410 at 4. In their written argument, the employer essentially advanced two points in response to this conclusion. The employer first argued that they would have found claimant an alternative to quitting work had he approached them with his concerns about contracting the norovirus and spreading it to his elderly parents. They also suggested that, at the time claimant quit, there was little risk of his contracting the norovirus at work. Neither of these assertions are supported by the record.

As to the latter, the employer indicated in their written argument that the norovirus outbreak at their facility lasted only until about mid-January 2020—about a month prior to the date on which claimant quit—suggesting that the danger had passed by the time claimant quit. Even if the outbreak did resolve by that time, however, it was reasonable for claimant to expect that additional outbreaks would occur in the future; the employer in fact admitted as much during their testimony. Thus, had claimant continued to work for the employer, he would likely have encountered future outbreaks at work and would therefore have been at risk of contracting norovirus and spreading it to his parents.

As to the former, the employer confirmed on the record that while they offered claimant alternate work schedules and part-time remote work, they were not able to offer claimant full-time remote work. As

such, claimant would have been required to work on-site—thereby exposing himself and his parents to

risk—under all circumstances contemplated on the record. The employer did not contradict this fact in their written argument. Because none of possible alternatives on the record—including alternate work schedules, part-time remote work, and a leave of absence—would have eliminated this risk to claimant's parents, none were reasonable alternatives to quitting.

On reconsideration, EAB reviewed the entire hearing record and claimant's timely filed written argument. On *de novo* review and pursuant to ORS 657.275(2), the hearing decision under review is again **adopted**.

DECISION: On reconsideration, Order No. 20-UI-152410 is re-affirmed.
