EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0562

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 11, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective November 17, 2019 (decision # 151715). Claimant filed a timely request for hearing. On April 9, 2020, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for April 16, 2020 at 8:15 a.m., at which claimant failed to appear. On April 16, 2020, ALJ Monroe issued Order No. 20-UI-148245 dismissing claimant's request for hearing because claimant failed to appear for the April 16, 2020 hearing, and leaving decision # 151715 undisturbed. On May 2, 2020, claimant filed a timely request to reopen the April 16, 2020 hearing. On May 8, 2020, OAH served, by mail, notice of a telephone hearing scheduled for May 19, 2020 to consider claimant's request to reopen, and if granted, the merits of decision # 151715.

On May 19, 2020, ALJ Smith conducted a hearing at which the employer failed to appear and on May 27, 2020, issued Order No. 20-UI-150327, canceling Order No. 20-UI-148245, allowing claimant's request to reopen, and affirming decision # 151715. On June 16, 2020, Order No. 20-UI-150327 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On June 26, 2020, claimant filed a late application for review of Order No. 20-UI-150327 with EAB.

FINDINGS OF FACT: (1) Order No. 20-UI-150327 mailed on May 27, 2020 stated, "You may appeal this decision by filing the attached Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 20-UI-150327 at 5. Order No. 20-UI-150327 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 16, 2020 to be timely."

(2) On June 11, 2020, claimant signed the application for review to EAB. The application for review was not postmarked until June 26, 2020. EAB received claimant's late application for review on June 30, 2020.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-150927 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). OAR 471-041-0065(1)(b) provides, in relevant part, that the filing date for an application for review to EAB is established as follows: "If mailed, the filing date is the date that the document is deposited in the United States mail in an envelope with first class postage, as evidenced by the postmark affixed to the envelope by the United States Postal Service." OAR 471-041-0065(1) (May 13, 2019).

The deadline for claimant's application for review was June 16, 2020. The postmark date on the envelope in which claimant mailed the application for review was June 26, 2020. Claimant's application for review was therefore filed late.

The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

Claimant did not provide a written statement with the late application for review. Therefore, claimant did not describe circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed June 26, 2020 is dismissed. Order No. 20-UI-150327 remains undisturbed.
