

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0563

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 11, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work during the weeks from June 18, 2017 through August 5, 2017, and until the reason for the denial had ended (decision # 84240). On January 2, 2018, decision # 84240 became final without claimant having filed a timely request for hearing. On June 18, 2020, claimant filed a late request for hearing. On June 30, 2020, ALJ Kangas issued Order No. 20-UI-151693, dismissing claimant's late request for hearing, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 14, 2020. On July 8, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on July 13, 2020 issued Order No. 20-UI-152121, re-dismissing claimant's late request for hearing, leaving decision # 84240 undisturbed. On July 30, 2020, claimant filed a timely application for review of Order No. 20-UI-152121 with the Employment Appeals Board (EAB).

With their application for review, claimant submitted a written argument. EAB considered claimant's argument to the extent it was based on the hearing record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-152121 is affirmed.
