

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0565**

*Affirmed*  
*Late Request for Hearing Allowed*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On April 23, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that when claimant filed claims for benefits for the weeks from December 15, 2019 through January 25, 2020 (weeks 51-19 through 04-20) he failed to disclose a material fact and was overpaid \$1,897 in benefits he was required to repay to the Department (decision # 82158). On May 13, 2020, decision # 82158 became final without claimant filing a timely request for hearing. On June 1, 2020, claimant filed a late request for hearing. On June 22, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 7, 2020 to consider whether claimant's late request should be allowed and, if so, the merits of decision # 82158. On July 7, 2020, ALJ Monroe conducted a hearing, and on July 15, 2020 issued Order No. 20-UI-152218, allowing claimant's late request for hearing, but affirming decision # 82158. On August 4, 2020, claimant filed a timely application for review of Order No. 20-UI-152218 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record and the written argument claimant submitted with his application for review to the extent it was based on the hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-152218 is affirmed.
