EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0572

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective January 26, 2020 (decision #82637). Claimant filed a timely request for hearing. On March 27, 2020, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for April 9, 2020 at 9:30 a.m., at which claimant failed to appear. On April 13, 2020, claimant filed a request to reopen the April 9, 2020 hearing. On April 15, 2020, ALJ J. Williams issued Order No. 20-UI-148159 dismissing claimant's request for hearing because claimant failed to appear for the April 9, 2020 hearing, and leaving decision #82637 undisturbed. On April 29, 2020, OAH served, by mail, notice of a telephone hearing scheduled for May 13, 2020 to consider claimant's request to reopen, and if granted, the merits of decision #82637.

On May 13, 2020, ALJ Murdock conducted a hearing and on May 14, 2020, issued Order No. 20-UI-149758, denying claimant's request to reopen the April 9, 2020 hearing and leaving 20-UI-148159 undisturbed. On June 3, 2020, Order No. 20-UI-149758 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On June 4, 2020, claimant filed a late application for review of Order No. 20-UI-149758 with EAB.¹

EAB considered claimant's written argument in reaching this decision.

FINDING OF FACT: (1) Order No. 20-UI-149758 mailed to claimant on May 14, 2020 stated, "You may appeal this decision by filing the attached Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 20-UI-149758 at 4. Order No. 20-UI-149758 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before June 3, 2020 to be timely."

¹ The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed her application for review was June 4, 2020; that date is therefore the filing date.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-149758 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-149758 was due June 3, 2020. Because claimant did not file the application for review until June 4, 2020, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed June 4, 2020 is dismissed. Order No. 20-UI-149758 remains undisturbed.
