

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0574

Late Application for Review Dismissed

PROCEDURAL HISTORY AND FINDINGS OF FACT: On January 16, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, and claimant was disqualified from receiving unemployment insurance benefits effective December 22, 2019 (decision # 85326). On February 5, 2020, decision # 85326 became final without claimant having filed a timely request for hearing.

On February 20, 2020, claimant filed a late request for hearing. On February 26, 2020, ALJ Kangas issued Order No. 20-UI-145132, dismissing claimant's request for hearing as late without a showing of good cause, subject to his right to renew the request by filing a response to an appellant questionnaire by March 11, 2020. On March 2, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on March 12, 2020 issued Order No. 20-UI-146130, concluding re-dismissing claimant's late request for hearing, leaving decision # 85326 undisturbed. On April 1, 2020, Order No. 20-UI-146130 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On August 9, 2020, claimant filed a late application for review of Order No. 20-UI-146130 with EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-146130 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-146130 was due April 1, 2020. Because claimant did not file the application for review until August 9, 2020, the application for review was late. Claimant

provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that resulted in him filing his application for review late. Claimant therefore did not show good cause to extend the filing deadline a reasonable time. Claimant's late application for review therefore is dismissed.

DECISION: The application for review filed August 9, 2020 is dismissed. Order No. 20-UI-146130 remains undisturbed.
