

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0575

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On June 11, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective June 2, 2019 (decision # 63620). On July 1, 2020, decision # 63620 became final without claimant filing a request for hearing.

On July 2, 2020, claimant filed a late request for hearing. On July 10, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 21, 2020 to consider claimant's late request for hearing, and if granted, the merits of decision # 63620. On July 21, 2020, ALJ Murdock conducted a hearing, and on July 22, 2020 issued Order No. 20-UI-152447, dismissing claimant's late request for hearing as without good cause, leaving decision # 63620 undisturbed. On August 11, 2020, claimant filed a timely application for review of Order No. 20-UI-152447 with the Employment Appeals Board (EAB).

Claimant filed a written argument in support of their application for review. Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-152447 is affirmed.
