

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0579**

*Late Applications for Review Dismissed*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On April 3, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective January 26, 2020 (decision # 152428), and another administrative decision concluding claimant quit work without good cause and was disqualified from receiving benefits effective February 9, 2020 (decision # 150531). Claimant filed a timely request for hearing on both decisions. On May 7, 2020, ALJ Frank conducted a separate hearing on each decision, and on May 12, 2020 issued Order No. 20-UI-149610 affirming decision # 152428, and Order No. 20-UI-149608 affirming decision # 150531. On June 1, 2020, Orders No. 20-UI-149610 and 20-UI-149608 became final without claimant having filed applications for review with the Employment Appeals Board (EAB). On August 13, 2020, claimant filed late applications for review of both orders.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-149610 and 20-UI-149608. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0579 and 2020-EAB-0580).

**CONCLUSIONS AND REASONS:** Claimant's applications for review are dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders 20-UI-149610 and 20-UI-149608 were due June 1, 2020. Because claimant did not file her applications for review until August 13, 2020, the applications for review were late. Claimant provided a written statement with her applications for review. However, claimant's

written statement did not describe the circumstances that prevented claimant from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

**DECISION:** The applications for review filed August 13, 2020 are dismissed. Orders No. 20-UI-149610 and 20-UI-149608 remain undisturbed.
