

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0583

Affirmed
Ineligible Weeks 13-20 through 31-20

PROCEDURAL HISTORY: On July 9, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able to work during the weeks including March 22 through July 4, 2020 (weeks 13-20 through 27-20) and until the reason for the denial had ended (decision # 112551). Claimant filed a timely request for hearing. On August 6, 2020, ALJ Griffin conducted a hearing, and on August 10, 2020, issued Order No. 20-UI-152969, modifying the Department's decision to include, with the consent of the parties, the weeks of July 5 through August 1, 2020 and concluding that claimant was not able to work during each of the weeks including March 22 through August 1, 2020 (weeks 13-20 through 31-20). On August 14, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written argument in reaching this decision. In her argument, claimant asserted that the order under review was incorrect because it was issued without consideration of claimant's medical records, which were not part of the record at hearing. Written Argument at 1. However, claimant's records were received by the Office of Administrative Hearings (OAH) after the hearing and included in the record as Exhibit 2. Order No. 20-UI-152969 at 3. For the reasons stated in the order under review, any delay in claimant's treatment that may have been caused by the COVID-19 pandemic, as reflected in Exhibit 2, was not relevant to the issues under review.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-152969 is affirmed.
