

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0594**

*Affirmed*  
*Disqualification*

**PROCEDURAL HISTORY:** On June 29, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective February 23, 2020 (decision # 121500). Claimant filed a timely request for hearing. On August 11, 2020, ALJ Scott conducted a hearing, and on August 13, 2020 issued Order No. 20-UI-153096, affirming the Department's decision. On August 29, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted a written argument in support of their application for review. Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090. EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-153096 is affirmed.<sup>1</sup>

<sup>1</sup> This denial is confined to claimant's disqualification from regular unemployment insurance benefits because of this work separation. However, claimant might be eligible for benefits under one of the Department's other unemployment insurance benefit programs, which are specifically intended as income replacement for individuals unemployed due to the COVID-19 pandemic.
