EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0601

Application for Review Dismissed Without Prejudice

FINDINGS OF FACT AND PROCEDURAL HISTORY: On December 4, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective October 20, 2019 (decision # 132326). On December 24, 2019, decision # 132326 became final without claimant having filed a timely request for hearing.

On March 10, 2020, claimant filed a late request for hearing on decision # 132326. ALJ Kangas reviewed claimant's hearing request, and on March 12, 2020 issued Order No. 20-UI-146094, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by March 26, 2020. On March 18, 2020, claimant filed a timely response to the appellant questionnaire. On July 2, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 17, 2020 on whether to allow claimant's late request for hearing, and if so, the merits of decision # 132326.

On July 17, 2020, ALJ Monroe conducted a hearing, and on July 24, 2020 issued Order No. 20-UI-152509, allowing claimant's late request for hearing and concluding the employer discharged claimant, but not for misconduct. On August 13, 2020, Order No. 20-UI-152509 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On August 19, 2020, the employer filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed without prejudice.

On August 19, 2020, the appellant filed an application for review of Order No. 20-UI-152509 with the EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than August 13, 2020. The appellant's application for review therefore is late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. See ORS 657.875; OAR 471-041-0070. If the appellant believes they have good cause and

filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145.

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed, September 17, 2020, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received the ALJ's order (Order No. 20-UI-152509), whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond its reasonable control prevented them from filing a timely application for review, *and*
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date (the date referred to in #4).

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or
- 2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@oregon.gov, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed August 19, 2020 is dismissed without prejudice. Order No. 20-UI-152509 remains undisturbed.
