

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0608

Affirmed
No Disqualification

PROCEDURAL HISTORY: On February 28, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct and claimant was disqualified from receiving unemployment insurance benefits effective January 5, 2020 (decision # 80159). On March 19, 2020, decision # 80159 became final without claimant having filed a timely request for hearing.

On June 11, 2020, claimant filed a late request for hearing. On June 22, 2020, ALJ Kangas issued Order No. 20-UI-151331, dismissing claimant's late request for hearing subject to claimant's right to renew the request by responding to an appellant questionnaire by July 6, 2020. On July 6, 2020, claimant filed a timely response to the appellant questionnaire. On July 8, 2020, the Office of Administrative Hearings (OAH) mailed a letter to the parties stating that Order No. 20-UI-151331 was cancelled. On July 13, 2020, OAH mailed notice of a hearing scheduled for July 24, 2020 to consider claimant's late request for hearing, and if granted, the merits of decision # 80159.

On July 24, 2020, ALJ S. Lee conducted a hearing at which the employer failed to appear, and on July 29, 2020, issued Order No. 20-UI-152640 granting claimant's late request for hearing and concluding the employer discharged claimant, but not for misconduct and claimant was not disqualified from receiving benefits. On August 17, 2020, claimant filed a timely application for review of Order No. 20-UI-152640 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-152640 is affirmed.
