

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0614

Affirmed
No Disqualification

PROCEDURAL HISTORY: On May 18, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct and claimant was disqualified from receiving unemployment insurance benefits, effective February 2, 2020 (decision # 63136). Claimant filed a timely request for hearing. On June 18, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for July 2, 2020 at 9:30 a.m. On July 2, 2020, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 20-UI-151796, dismissing claimant's request for hearing for failure to appear, leaving decision # 63136 undisturbed.

On July 21, 2020, claimant filed a timely request to reopen the July 2, 2020 hearing. On July 29, 2020, OAH mailed notice of a hearing scheduled for August 11, 2020 at 9:30 a.m. to consider claimant's request to reopen and, if granted, the merits of decision # 63136. On August 11, 2020, ALJ Murdock conducted a hearing at which the employer failed to appear, and on August 12, 2020 issued Order No. 20-UI-153057, granting claimant's reopen request and concluding that the employer discharged claimant, but not for misconduct, and that claimant was not disqualified from receiving benefits.

On August 18, 2020, the employer filed a timely request to reopen the August 11, 2020 hearing. On August 19, 2020, OAH mailed notice of a hearing scheduled for September 1, 2020 at 10:45 a.m. to consider the employer's request to reopen and, if granted, the merits of decision # 63136. On September 1, 2020, ALJ Frank conducted a hearing at which both parties appeared, and on September 9, 2020 issued Order No. 20-UI-153753, granting the employer's reopen request and again concluding that the employer discharged claimant, but not for misconduct, and that claimant was not disqualified from receiving benefits. On September 16, 2020, the employer filed an application for review of Order No. 20-UI-153753 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-153753 is affirmed.
