EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0616

Late Application for Review Dismissed

PROCEDURAL HISTORY: On February 19, 2016, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessing a \$3,984 overpayment, a \$1,195.20 monetary penalty, and a 29 week penalty disqualification from future benefits (decision #211381). On March 9, 2016, claimant filed a timely request for hearing by telephone. On March 29, 2016, claimant contacted the Office of Administrative Hearings (OAH) by telephone and requested to withdraw his request for hearing.

ALJ Seideman reviewed claimant's request to withdraw his request for hearing, and on March 29, 2016, issued Order No. 16-UI-55968, granting the request and dismissing claimant's request for hearing, leaving decision #211381 undisturbed. On April 18, 2016, Order No. 16-UI-55968 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On September 1, 2020, claimant filed a late application for review of Order No. 16-UI-55968 with EAB.

EAB considered claimant's written argument in reaching this decision.

FINDING OF FACT: (1) Order No. 16-UI-55968, mailed to claimant on March 29, 2016, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 16-UI-55968 at 1. Order No. 16-UI-55968 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before April 18, 2016 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 16-UI-55968 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable

control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 16-UI-55968 was due April 18, 2016. Because claimant did not file the application for review until September 1, 2020, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed September 1, 2020 is dismissed. Order No. 16-UI-55968 remains undisturbed.
