# EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0618

Affirmed
Ineligible for Regular and FPUC Benefits Weeks 13-20 through 36-20

**PROCEDURAL HISTORY:** On July 29, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was disqualified from receiving regular unemployment insurance benefits from March 22 through July 25, 2020, and until the reason for the denial had ended, because claimant would be receiving retirement pay that would be equal to or exceed claimant's weekly benefit amount for those weeks (decision # 92419). Claimant filed a timely request for hearing. On September 10, 2020, ALJ S. Lee conducted a hearing, and on September 11, 2020 issued Order No. 20-UI-153883, modifying the Department's decision. Order No. 20-UI-153883 concluded claimant was ineligible to receive regular or Federal Pandemic Unemployment Compensation (FPUC) benefits from March 22 through September 5, 2020 (weeks 13-20 through 36-20) because claimant received retirement pay that was equal to or exceeded claimant's weekly benefit amount. Order No. 20-UI-153883 further concluded that because claimant would not receive any regular benefits for those weeks, he also was ineligible for FPUC benefits. On September 15, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-153883 is affirmed.
