

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0620**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On November 9, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits, and assessing a \$3,132 overpayment, a \$939.60 monetary penalty, and a 22 week penalty disqualification from future benefits (decision # 195638). On November 29, 2017, decision # 195638 became final without claimant having filed a timely request for hearing.

On May 3, 2020, claimant filed a late request for hearing. On June 2, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for June 12, 2020. On June 12, 2020, ALJ Janzen conducted a hearing, at which the employer failed to appear, and on June 16, 2020, issued Order No. 20-UI-151084, allowing claimant's late request for hearing.

On July 24, 2020, OAH mailed notice of a hearing scheduled for August 7, 2020 at 10:45 a.m. to address the merits of decision #195638. On August 7, 2020, claimant failed to appear for the hearing, and ALJ S. Lee issued Order No. 20-UI-152955, dismissing claimant's request for hearing for failing to appear.

On August 26, 2020, claimant filed a timely request to reopen the August 7, 2020 hearing. ALJ Kangas reviewed claimant's request, and on September 1, 2020, issued Order No. 20-UI-153513, denying claimant's request to reopen. On September 19, 2020, claimant filed a timely application for review of Order No. 20-UI-153513 with the Employment Appeals Board (EAB).

With the application for review, claimant submitted a written argument. Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-

0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information with their request to reopen. Under ORS 657.275(2) and OAR 471-041-0090, EAB considered only information included within the case record when reaching this decision.

EAB reviewed the entire record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-153513 is affirmed.
