EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0641

Affirmed Disqualification

PROCEDURAL HISTORY: On August 14, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was disqualified from benefits beginning March 29, 2020 because she received retirement pay that equaled or exceeded her weekly benefit amount (decision #72056). Claimant filed a timely request for hearing. On September 22, 2020, ALJ Scott conducted a hearing, and on September 23, 2020 issued Order No. 20-UI-154275, affirming the Department's decision. On September 29, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB considered claimant's written arguments when reaching this decision.

FINDINGS OF FACT: (1) In 2012, claimant began receiving retirement benefits from the Oregon Public Employees' Retirement System (PERS). Claimant's weekly retirement pay amount was \$323.80.¹

- (2) After retiring, claimant worked for various school districts, including Harrisburg School District #7, Lane County School District #52, Lane Education Services District, School District 4J Lane County, Monroe School District IJ, and Central Linn Schools, District #552C. At least one of those school districts contributed to PERS.
- (3) By April 2020, the school districts had closed due to the COVID-19 pandemic and no longer had work available for claimant.
- (4) On April 5, 2020, claimant filed her initial claim for unemployment insurance benefits.
- (5) The base year of claimant's claim was January 1, 2019 through December 31, 2019. Claimant's base year employers included Harrisburg School District #7, Lane County School District #52, Lane

Education Services District, School District 4J Lane County, Monroe School District IJ, and Central Linn Schools, District #552C.

(6) Claimant filed weekly claims for benefits from March 29, 2020 through May 16, 2020 (weeks 14-20 through 20-20), the weeks at issue. Claimant's weekly benefit amount was \$308. The Department did not pay claimant benefits for the weeks at issue.

CONCLUSIONS AND REASONS: Claimant is disqualified from benefits because she receives retirement benefits that exceed her weekly benefit amount.

ORS 657.205 provides, "an individual is disqualified for benefits for any week with respect to which the individual is receiving, will receive, or has received a governmental or other pension, retirement or retired pay, annuity, or other similar periodic payment based on the previous work of the individual, if payment is received under a plan maintained or contributed to by a base year employer of the individual."

There is no material dispute in this case that claimant received PERS retirement benefits in an amount that exceeded her unemployment insurance weekly benefit amount, and that at least one of claimant's base year employers contributed to PERS. Claimant argued at the hearing and in her written argument that she should still receive benefits because none of her base year employers contributed to PERS on her behalf. It is immaterial to this decision whether claimant's base year employers contributed to PERS on claimant's behalf or not, because under ORS 657.205 if base year employer(s) contributed to PERS on anyone's behalf – and claimant is receiving PERS benefits, she is disqualified from benefits if her weekly PERS benefit exceeds her weekly unemployment insurance benefits. Because claimant's PERS benefits exceed claimant's weekly unemployment insurance benefit amount by \$15.80, claimant is disqualified from receiving unemployment insurance benefits.

DECISION: Order No. 20-UI-154275 is affirmed.
