

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0644

Affirmed
Ineligible

PROCEDURAL HISTORY: On June 29, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not able to work from March 29, 2020 through June 20, 2020, and until the reason for the denial ended (decision # 71519). Claimant filed a timely request for hearing. On September 8, 2020, ALJ Frank conducted a hearing, and on September 15, 2020 issued Order No. 20-UI-153995, affirming decision # 71519 and concluding claimant was not able to work from March 29, 2020 through September 5, 2020. On September 30, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-153995 is affirmed.¹
