EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0646

Late Application for Review Dismissed

PROCEDURAL HISTORY: On March 2, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct and claimant was disqualified from receiving unemployment insurance benefits, effective January 5, 2020 (decision # 130708). Claimant filed a timely request for hearing. On March 18, 2020, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for April 2, 2020 at 8:15 a.m. On April 2, 2020, claimant failed to appear at the hearing, and ALJ Shoemake issued Order No. 20-UI-147355, dismissing claimant's request for hearing for failure to appear, leaving decision # 130708 undisturbed. On April 22, 2020, Order No. 20-UI-147355 became final without claimant having filed a timely request to reopen the hearing.

On June 3, 2020, claimant filed a late request to reopen the April 2, 2020 hearing. ALJ Kangas considered claimant's request, and on June 16, 2020 issued Order No. 20-UI-151111, dismissing claimant's request to reopen as late without a showing of good cause, leaving Order No. 20-UI-147355 and decision #130708 undisturbed. On July 6, 2020, Order No. 20-UI-151111 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On October 2, 2020, claimant filed a late application for review of Order No. 20-UI-151111 with EAB.

FINDING OF FACT: (1) Order No. 20-UI-151111, mailed to claimant on June 16, 2020, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 20-UI-151111 at 4. Order No. 20-UI-151111 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before July 6, 2020 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-151111 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-

041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-151111 was due July 6, 2020. Because claimant did not file their application for review with EAB until October 2, 2020, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review with EAB on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed October 2, 2020 is dismissed. Order No. 20-UI-151111 remains undisturbed
