

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0650

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On July 31, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective January 19, 2020 (decision # 95636). On August 20, 2020, decision # 95636 became final without claimant having filed a timely request for hearing. On August 24, 2020, claimant filed a late request for hearing. On September 14, 2020, ALJ Kangas issued Order No. 20-UI-153933, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 28, 2020. On September 28, 2020, claimant filed a timely response to the appellant questionnaire. ALJ Kangas reviewed claimant's response, and on September 29, 2020 issued Order No. 20-UI-154507, re-dismissing claimant's late request for hearing, leaving decision # 95636 undisturbed. On October 5, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

Claimant submitted a written argument with the application for review. Claimant's argument contained information that was not part of the record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information in his questionnaire response. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into the record when reaching this decision.

EAB reviewed the entire case record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**. Decision # 95636 remains undisturbed.

DECISION: Order No. 20-UI-154507 is affirmed.¹

¹ This dismissal is confined to claimant's disqualification from regular unemployment insurance benefits under decision # 95636. However, claimant might be eligible for benefits under one of the Department's other unemployment insurance benefit programs, which are specifically intended as income replacement for individuals unemployed due to the COVID-19 pandemic.
