EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0658

Affirmed Ineligible Weeks 18-20 through 21-20

PROCEDURAL HISTORY: On August 5, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant was not available for work from April 26, 2020 through May 23, 2020 because she was absent from her labor market (decision # 111842). Claimant filed a timely request for hearing. On September 22, 2020, ALJ Logan conducted a hearing, and on September 23, 2020 issued Order No. 20-UI-154282, affirming decision # 111842. On October 8, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

FINDINGS OF FACT: (1) On April 7, 2020, claimant filed an initial claim for unemployment insurance benefits. She filed weekly claims for benefits from April 26, 2020 through May 23, 2020 (weeks 18-20 through 21-20), the weeks at issue.

(2) Claimant's normal labor market included Eugene, Oregon. From April 26, 2020 through May 25, 2020, claimant traveled to Nebraska to spend time with family. While in Nebraska, claimant sought work in Oregon. At all relevant times, claimant did not seek work located in Nebraska, did not intend to move her residence to Nebraska, and was not willing to work in Nebraska.

CONCLUSIONS AND REASONS: Claimant was not available for work during the weeks at issue.

To be eligible to receive benefits, unemployed individuals must be available for work during each week claimed. ORS 657.155(1)(c). Under ORS 657.155(2), "[a]n individual who leaves the individual's normal labor market area for the major portion of any week is presumed to be unavailable for work within the meaning of this section"; the presumption may be overcome if claimant searched for work in the labor market area in which she spent the major portion of the week or was required to be outside the normal labor market area to apply for work within the normal labor market area.

For an individual to be considered "available for work" for purposes of ORS 657.155(1)(c), they must be "[p]hysically present in the normal labor market area" every day of the week claimed. OAR 471-030-0036(3) (August 2, 2020 through December 26, 2020). The "normal labor market area" is the "geographic area surrounding the individual's permanent residence within which employees in similar

circumstances are generally willing to commute to seek and accept the same type of work at a comparable wage." OAR 471-030-0036(6)(a).

During the weeks at issue, claimant was not physically present in her Eugene, Oregon labor market. She was in Nebraska, and is therefore presumed unavailable for work unless she sought work in Nebraska, or was required to be in Nebraska for the purpose of seeking work in Eugene. Claimant therefore was not available for work under ORS 657.155.

Claimant did not seek work in Nebraska. Claimant applied for work in Oregon while she was staying in Nebraska, but she was not required to be in Nebraska to seek or apply for work in Oregon. Claimant therefore did not overcome the presumption that she was not available for work when she traveled outside her Eugene, Oregon labor market.

Claimant was not available for work during weeks 18-20 through 21-20. She is therefore ineligible for benefits during those weeks.

DECISION: Order No. 20-UI-154282 is affirmed.
