**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0661**

---

*Affirmed  
Ineligible for Extended Benefits*

**PROCEDURAL HISTORY:** On August 6, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not eligible for extended benefits. Claimant filed a timely request for hearing. On September 24, 2020, ALJ Davis conducted a hearing at which a Department representative failed to appear, and as a result, postponed the hearing. On October 2, 2020, ALJ Davis held a hearing in which both claimant and a Department representative participated, and on October 2, 2020 issued Order No. 20-UI-154764, affirming the Department's August 6, 2020 decision. On October 13, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

**EVIDENTIARY MATTER:** The ALJ admitted Exhibit 1 into evidence at the October 2, 2020 hearing. Audio Record at 11:21; Order No. 20-UI-154764 at 1. However, the ALJ failed to mark Exhibit 1. Because the ALJ described the content of Exhibit 1 during the hearing and the documents were readily identifiable, EAB marked the documents as Exhibit 1 as a clerical matter. Audio Record at 11:01 to 12:00.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 20-UI-154764 is affirmed.
