EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0670

Affirmed Disqualification

PROCEDURAL HISTORY: On June 18, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit work without good cause and was disqualified from receiving unemployment insurance benefits effective December 1, 2019 (decision # 92526). Claimant filed a timely request for hearing. On July 20, 2020, ALJ Smith conducted a hearing, and on July 23, 2020 issued Order No. 20-UI-152465, affirming decision # 92526. On August 11, 2020, claimant filed an application for review with the Employment Appeals Board (EAB). On September 2, 2020, EAB issued Appeals Board Decision 2020-EAB-0576, reversing this matter and remanding for further development of the record. On September 22, 2020, ALJ Smith conducted a hearing, and on October 1, 2020 issued Order No. 20-UI-154655, again affirming decision # 92526. On October 20, 2020, claimant filed an application for review with EAB.

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB considered claimant's written argument to the extent that it was based on evidence already in the hearing record. Even when considering claimant's argument in its entirety, though, claimant has not set forth facts showing that she quit for good cause. Claimant's main contention appears to be that the employer was required—by law or otherwise—to specifically notify her prior to quitting that a leave of absence was available to her, and that the employer's failure to do so therefore suggests that seeking a leave of absence was not a reasonable alternative to quitting. Neither claimant's argument nor the evidence in the record explain, however, why requesting a leave of absence from the employer would not have been a reasonable alternative to quitting. In a voluntary leaving case, claimant has the burden of proving good cause by a preponderance of evidence. *Young v. Employment Department*, 170 Or App 752, 13 P3d 1027 (2000). For the foregoing reason, claimant has not met that burden here.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-154655 is affirmed.
