EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0672-R

Request for Reconsideration Dismissed

FINDINGS OF FACT AND PROCEDURAL HISTORY: On February 12, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits effective November 10, 2019 (decision # 144224). On March 3, 2020, decision # 144224 became final without claimant having filed a timely request for hearing.

On September 2, 2020, claimant filed a late request for hearing. On September 14, 2020, ALJ Kangas issued Order No. 20-UI-153895, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 28, 2020. On October 5, 2020, Order No. 20-UI-153895 became final without claimant having filed a response to the appellant questionnaire or an application for review of Order No. 20-UI-153895 with the Employment Appeals Board (EAB).

On October 6, 2020, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 20-UI-153895 with EAB. On October 8, 2020, ALJ Kangas mailed a letter stating that because claimant's response to the questionnaire was late, it would not be considered, another order would not be issued, and Order No. 20-UI-153895 remained in effect. This matter came before EAB based on claimant's late application for review of Order No. 20-UI-153895.

On October 29, 2020, EAB issued Appeals Board Decision 2020-EAB-0672, dismissing claimant's late application for review without prejudice and giving claimant the opportunity to request reconsideration of that decision under OAR 471-041-0145 (May 13, 2019) if the request included the information specified in Appeals Board Decision 2020-EAB-0672.

On November 15, 2020, claimant filed a timely request for reconsideration of Appeals Board Decision 2020-EAB-0672, but failed to describe circumstances that established good cause for their late application for review under OAR 471-041-0070 or declare that they sent a copy of the request to the other party, both of which were required by Appeals Board Decision 2020-EAB-0672. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration should be dismissed.

On November 15, 2020, claimant filed a request for reconsideration of Appeals Board Decision 2020-EAB-0672. In their request for reconsideration, claimant failed to describe circumstances that established good cause for their late application for review under OAR 471-041-0070 or declare that they sent a copy of the request to the other party, both of which were required by Appeals Board Decision 2020-EAB-0672. Moreover, a request for reconsideration is subject to dismissal under OAR 471-041-0145(2) unless it includes a statement that a copy was provided to the other parties. OAR 471-041-0145(2)(a). Accordingly, claimant's request for reconsideration is dismissed. Appeals Board Decision 2020-EAB-0672 remains undisturbed, and EAB will take no further action with regard to this matter.

DECISION: The request for reconsideration filed November 15, 2020 is dismissed. Order No. 20-UI-153895 remains undisturbed.
