# EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0675

# Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On March 25, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding the employer discharged claimant for misconduct, disqualifying claimant from receiving benefits beginning January 26, 2020 (decision # 102823). Claimant filed a timely request for hearing. On April 22, 2020, ALJ Snyder conducted a hearing, and on April 23, 2020 issued Order No. 20-UI-148674, affirming the Department's decision. On May 13, 2020, Order No. 20-UI-148674 became final without claimant having filed an application for review by the Employment Appeals Board (EAB). On July 16, 2020, claimant filed a late application for review by EAB. EAB received claimant's application for review on October 22, 2020.

**FINDING OF FACT:** (1) Order No. 20-UI-148674, mailed to claimant on April 23, 2020, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date this decision is mailed." Order No. 20-UI-148674 at 4. Order No. 20-UI-148674 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before May 13, 2020 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 20-UI-148674 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-148674 was due May 13, 2020. Because claimant did not file their application for review until July 16, 2020, the application for review was late. Claimant

provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed July 16, 2020 is dismissed. Order No. 20-UI-148674 remains undisturbed.
