

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0683**

*Application for Review Dismissed*

**FINDINGS OF FACT AND PROCEDURAL HISTORY:** On September 25, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant received retirement pay that reduced their weekly benefit amount by \$160 per week from April 5, 2020 through June 13, 2020 (decision # 91850). Claimant filed a timely request for hearing. On October 15, 2020, ALJ M. Davis conducted a hearing, and on October 16, 2020 issued Order No. 20-UI-155365, modifying the administrative decision and concluding claimant was not eligible to receive benefits from April 5, 2020 through June 13, 2020. On October 23, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

**CONCLUSIONS AND REASONS:** The application for review should be dismissed.

On November 2, 2020, EAB received a letter in which the appellant withdrew the application for review of Order No. 20-UI-155365. Under OAR 471-041-0098, the appellant's request to withdraw is allowed.

**DECISION:** The application for review filed October 23, 2020 is dismissed. Order No. 20-UI-155365 remains undisturbed.
