EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0684

Affirmed Disqualification

PROCEDURAL HISTORY: On September 17, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant voluntarily left work without good cause and was disqualified from receiving unemployment insurance benefits effective May 17, 2020 (decision #120147). Claimant filed a timely request for hearing. On October 12, 2020, ALJ J. Williams conducted a hearing, and on October 20, 2020 issued Order No. 20-UI-155417, affirming the Department's decision. On October 26, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

The record supports the conclusion in Order No. 20-UI-155417 that claimant quit work without good cause. The record shows that claimant sent an email to human resources before he began work and that a human resources representative "assured" claimant that the employer had COVID-19 "rules and standards in place." Transcript at 6. During claimant's one week of work, he was concerned about what he considered to be a lack of enforcement of safety precautions to avoid the spread of COVID-19 in the workplace. However, despite having contacted human resources about COVID-19 safety precautions before he began work, claimant did not contact human resources again until he did so to quit work. Rather than quit work when he did, claimant had the reasonable alternative of contacting human resources about his concerns that the employer was not enforcing social distancing and other precautions to avoid the spread of COVID-19 in the workplace. The record shows that it would not have been futile for claimant to have done so because human resources would have intervened to enforce "the 6 [foot] distancing." Transcript at 18.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-155417 is affirmed.
