

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0686**

*Reversed & Remanded*

**PROCEDURAL HISTORY:** On August 13, 2019, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$116 overpayment, a \$17.40 monetary penalty, and a one week penalty disqualification from future benefits (decision # 195829). On September 3, 2019, decision # 195829 became final without claimant having filed a timely request for hearing.

On August 6, 2020, claimant filed a late request for hearing on decision # 195829. On October 5, 2020, ALJ Kangas issued Order No. 20-UI-154816 dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by October 19, 2020. On October 20, 2020, claimant filed a late response to the appellant questionnaire and a timely application for review of Order No. 20-UI-154816 with the Employment Appeals Board (EAB). On October 26, 2020, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's October 20, 2020 application for review of Order No. 20-UI-154816.

**EVIDENTIARY RULING:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

**CONCLUSIONS AND REASONS:** Order No. 20-UI-154816 is set aside and this matter remanded for further development of the record.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Claimant's August 6, 2020 late hearing request email and claimant's responses to the appellant questionnaire regarding why the hearing request was late show that claimant was not aware of decision # 195829 until some unknown date around August 6, 2020. Exhibit 2, EAB Exhibit 1. Claimant's August 6, 2020 request for hearing explains that shortly after claimant claimed benefits on July 15, 2020, she received a letter stating that there "was an administrative decision issues [sic] on a prior claim" which imposed a penalty for misrepresentation, and that she had "no idea" about the decision. Exhibit 2. Claimant states in her response to the appellant questionnaire that she "did not have any idea an administrative decision was made nor that there was any issue until I tried to file in 2020." EAB Exhibit 1 at 2.

The record needs to be developed to determine if the 20-day deadline to request a hearing may be extended to August 6, 2020. The record does not contain sufficient information to determine whether factors beyond claimant's reasonable control or an excusable mistake prevented claimant from filing a timely request for hearing, and, if so, whether claimant's August 6, 2020 hearing request was made within a "reasonable time." A "reasonable time" is within seven days after the factors causing the delay ceased to exist. If claimant's request for hearing is allowed, an inquiry into the merits of decision # 195829 needs to be conducted.

Because further development of the record is necessary for a determination of whether claimant's request for hearing should be allowed, and, if so, on the merits of decision # 195829, Order No. 20-UI-154816 is reversed, and this matter is remanded.

**DECISION:** Order No. 20-UI-154816 is set aside, and this matter remanded for further proceedings consistent with this order.
