

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0688

Affirmed
Late Request for Hearing Allowed
Eligible Week 13-20

PROCEDURAL HISTORY: On August 20, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that benefits were not payable to claimant during the vacation recess, March 22, 2020 through March 28, 2020, because she had reasonable assurance of employment after the vacation recess (decision # 131250). On September 9, 2020, decision # 131250 became final without claimant having filed a timely request for hearing. On September 14, 2020, claimant filed a late request for hearing. On October 14, 2020, ALJ Monroe conducted a hearing, and on October 20, 2020, issued Order No. 20-UI-155442, allowing claimant's late request for hearing and concluding that claimant was eligible to receive benefits during the recess period. On October 23, 2020, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-155442 is affirmed.
