

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0691-R

Late Request for Reconsideration Dismissed

PROCEDURAL HISTORY: On September 21, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective June 28, 2020 (decision # 71041). Claimant filed a timely request for hearing. On October 15, 2020, ALJ Snyder conducted a hearing, and on October 22, 2020 issued Order No. 20-UI-155605, affirming the Department's decision. On October 31, 2020, claimant filed an application for review with the Employment Appeals Board (EAB). On December 8, 2020, EAB issued EAB Decision 2020-EAB-0691, affirming Order No. 20-UI-155605. On February 22, 2021, claimant filed a request for reconsideration of Order No. 20-UI-155605 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

FINDING OF FACT: EAB mailed Appeals Board Decision 2020-EAB-0691 to the parties on December 8, 2020.

CONCLUSIONS AND REASONS: Claimant's late request for reconsideration of Appeals Board Decision 2020-EAB-0691 is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the

other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB mailed Appeals Board Decision 2020-EAB-0691 on December 8, 2020. Under OAR 471-041-0145(2), the request for reconsideration was due by December 28, 2020. Claimant's request for reconsideration was filed on February 22, 2021, nearly two months after the timely filing deadline. In the request for reconsideration, claimant asked EAB to allow the request despite the fact that it was late. However, OAR 471-041-0145(2) contains no exception to the requirement that a request for reconsideration must be filed on or before the 20th day after the decision sought to be reconsidered was mailed. Claimant's request for reconsideration therefore is dismissed as untimely.

DECISION: The request for reconsideration filed February 22, 2021 is dismissed. Order No. 20-UI-155605 remains undisturbed.
