EMPLOYMENT APPEALS BOARD DECISION 2020-EAB-0703

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 16, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant committed a disqualifying act under the Department's drug and alcohol adjudication policy and was disqualified from receiving unemployment insurance benefits effective March 15, 2020 (decision # 82712). Claimant filed a timely request for hearing. On September 11, 2020, the Office of Administrative Hearings (OAH) served, by mail, notice of a telephone hearing scheduled for September 24, 2020 at 8:15 a.m., at which claimant failed to appear. On September 25, 2020, ALJ Murdock issued Order No. 20-UI-154397 dismissing claimant's request for hearing based on claimant's failure to appear at the September 24, 2020 hearing, leaving decision # 82712 undisturbed.

On October 9, 2020, claimant filed a timely request to reopen the September 24, 2020 hearing. ALJ Kangas considered claimant's request, and on October 14, 2020, issued Order No. 20-UI-155232, denying the request. On November 3, 2020, Order No. 20-UI-155232 became final without claimant having filed a timely application for review with the Employment Appeals Board (EAB). On November 4, 2020, claimant filed a late application for review of Order No. 20-UI-155232 with EAB.

EAB considered claimant's written argument and the envelope in which claimant mailed his application for review. A copy of the envelope has been provided to the parties with this decision.

FINDINGS OF FACT: (1) Order No. 20-UI-155232 mailed to claimant on October 14, 2020 stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 20-UI-155232 at 3. Order No. 20-UI-155232 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 3, 2020 to be timely."

(2) On November 4, 2020, claimant filed, by mail, an application for review of Order No. 20-UI-155232 with EAB. The postmark date on the envelope in which claimant mailed his application for review was November 4, 2020.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 20-UI-155232 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the decision for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20 day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 20-UI-155232 was due November 3, 2020. The filing date for an application for review filed by mail is the postmark date affixed to the envelope in which the application was mailed. OAR 471-041-0065(1)(b) (May 13, 2019). The postmark date on the envelope in which claimant mailed his application for review of Order No. 20-UI-155232 was November 4, 2020. Therefore, November 4, 2020 was the filing date of claimant's application for review. Because claimant did not file the application for review until November 4, 2020, the application for review was late.

Claimant provided a written statement with his application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review by the November 3, 2020 deadline. Accordingly, under OAR 471-041-0070(3), claimant did not show good cause for his late application for review, and his late application for review therefore is dismissed.

DECISION: The application for review filed November 4, 2020 is dismissed.¹ Order No. 20-UI-155232 remains undisturbed.
