

EMPLOYMENT APPEALS BOARD DECISION
2020-EAB-0713

Affirmed
Request for Adjustment of Claim Determination Denied

PROCEDURAL HISTORY: On July 15, 2020, the Oregon Employment Department (the Department) served notice of a claim determination decision concluding that the wages and hours of work claimant requested to have added to her claim determination could not be added because the wages were excluded per ORS 657.060. Claimant filed a timely request for hearing. On October 16, 2020, ALJ S. Lee conducted a hearing, and on October 23, 2020 issued Order No. 20-UI-155663, affirming the Department's decision. On November 12, 2020, claimant filed an application for review with the Employment Appeals Board (EAB).

On November 27, 2020, the employer faxed to EAB four pages regarding how to verify employment and income. To the extent the employer intended this information to be written argument, EAB did not consider it in reaching this decision. The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 20-UI-155663 is affirmed.
