

**EMPLOYMENT APPEALS BOARD DECISION**  
**2020-EAB-0716**

*Affirmed*  
*Late Requests for Hearing Dismissed*

**PROCEDURAL HISTORY:** On January 12, 2017, the Oregon Employment Department (the Department) served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits and assessing a \$378 overpayment, a \$56.70 monetary penalty, and a 3-week penalty disqualification from future benefits (decision # 193453). On February 1, 2017, decision # 193453 became final without claimant having filed a timely request for hearing. On August 2, 2017, the Department served notice of an administrative decision concluding claimant willfully made misrepresentations and failed to report material facts to obtain benefits and assessing a \$378 overpayment, a \$75.60 monetary penalty and a 52-week penalty disqualification from future benefits (decision # 194770). On August 22, 2017, decision # 194770 became final without claimant having filed a timely request for hearing.

On October 26, 2020, claimant filed late requests for hearing on decisions # 193453 and # 194770. On November 4, 2020, ALJ Kangas issued Order No. 20-UI-156079, dismissing claimant's late request for hearing on decision # 193453, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 18, 2020. On November 4, 2020, ALJ Kangas also issued Order No. 20-UI-156080, dismissing claimant's late request for hearing on decision # 194770, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 18, 2020.

On November 10, 2020, claimant filed timely responses to the appellant questionnaires by fax. ALJ Kangas reviewed claimant's questionnaire response regarding Order No. 20-UI-156079, and on November 12, 2020, issued Order No. 20-UI-156352 as a final order of dismissal cancelling Order No. 20-UI-156079, and leaving decision # 193453 undisturbed. ALJ Kangas also reviewed claimant's questionnaire response regarding Order No. 20-UI-156080, and on November 12, 2020, issued Order No. 20-UI-156350 as a final order of dismissal cancelling Order No. 20-UI-156080, and leaving decision # 194770 undisturbed. On November 17, 2020, claimant filed timely applications for review of Orders No. 20-UI-156352 and 20-UI-156350 by fax with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 20-UI-156352 and 20-UI-156350. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2020-EAB-0716 and 2020-EAB-0717).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 20-UI-156352 and 20-UI-156350 are affirmed. Decisions # 193453 and 194770 remain undisturbed.
